With a dielectric strength of 47,300 volts, it's safe to use around electrical equipment and power sources.

Ideal for use in warehouses, parking garages, picnic shelters, and other indoor/outdoor nesting sites.

DIRECTIONS FOR USE :

Carefully read all label instructions before use.

For best results, spray in early morning or late evening when insect activity is minimal. Stand a safe distance from nest and not directly underneath. Remove protective cap. Hold can upright and point spray opening toward nest with wind at your back. Spray until nest is thoroughly saturated to kill the entire nest population. Residual action will kill wasps and hornets returning to the nest. Wait at least 24 hours before removing the nest.

To kill wasps, hornets, yellow jackets and bees under eaves, screens, window frames, doors, patios, cracks, holes or crevices wherever insects are noticed, spray for about 1 - 2 seconds or until surfaces are moist.
