DIRECTIONS FOR USE

NOTE: A cleaning solution too concentrated can have a dulling effect on certain paints and inexpensive-grade varnishes. It is recommended to try the cleaning solution first on a small area.

DILUTION:

GENERAL CLEANING: For floors, steel furniture, porcelain surfaces, fixtures, tiles, windows and walls: Mix 2 to 3 ounces of No Issue with each gallon of water.

HEAVY DUTY CLEANING: For severely greasy or soiled floors, parts, equipment and machines: Mix 10 to 18 ounces of No Issue with each gallon of water.

COIL CLEANING: Mix up to 10 parts of water with ONE part of No Issue.

USE:

Apply No Issue solution to soiled surfaces, then agitate. Let No Issue do the work for 2 to 3 minutes, then wipe away with sponge or cloth. If needed, rinse with water.

IMPORTANT: No Issue is NOT for use with steam cleaning equipment.

FOR USE IN OIL / WATER SEPARATORS

No Issue is designed to work effectively with oil water separation equipment. No Issue does not use a strong emulsifying agent making it ideally suited for use in all brands of gravity displacement oil / water separators. No Issue can be diluted to meet any specific cleaning application - easily removing oil, grease, carbon and other industrial soils. No Issue effectively cleans by forming a loose emulsion. When the wash water is directed through a gravity displacement separator, the oils cleanly separate and break free from the water. The free oil can be easily skimmed off.
