WHERE TO USE:

Effective on all hard, non-porous, inanimate, surfaces such as walls, sinktops, tables, chairs, telephones, door knobs, light switches, shower stalls, hampers, cabinets and bed springs.

COMPLIANT AND EFFECTIVE

TUBERCULOCIDAL

EFFECTIVE AGAINST CANINE PARVOVIRUS

Use on inanimate, hard, non-porous surfaces such as kennel walls and floors, and veterinary examination tables and counters. Triple Quick kills the Canine Parvovirus, which is a potentially fatal disease for dogs and other members of the canine family.

BACTERICIDE

Effective against Staphylococcus aureus, Salmonella choleraesuis, and Pseudomonas aeruginosa. Triple Quick meets the strict requirements for hospital use.

FUNGICIDE

Kills pathogenic fungi (such as T. mentagrophytes, the fungus that causes Athlete's foot) on hard surfaces found in bathrooms, shower stalls, locker rooms and other clean, non-porous, hard surfaces commonly contacted by bare feet.

Controls mold and mildew effectively. Apply Triple Quick at weekly intervals or when mildew growth appears.
